Bharat Financial Inclusion Ltd extends its Mahapashudhan Sanjeevani initiative to Dharashiv in collaboration with Government of Maharashtra

Shirdi, Nashik, 26th March 2023: Bharat Financial Inclusion Ltd (BFIL), a wholly-owned subsidiary of IndusInd Bank, has collaborated with the Maharashtra State Rural Livelihood Mission (MSRLM) and Animal Husbandry department to extend their '*Maha pashudhan Sanjeevani*' initiative within the Dharashiv district. This association which had initially started in 2020, will help support women led A-HELP cadres in Dharashiv district of Maharashtra by providing veterinary services at doorstep of the farmers via a toll-free number - 1962. Besides this, women led A-HELP cadres will also be able to connect with veterinary doctors through the technology platform developed by BFIL.

Under the agreement, 40 Pashu Sakhi cadres (Accredited Agent for Health and Extension of Livestock Production- A HELP) from MSRLM of Dharashiv district will be trained by Department of Animal Husbandry for providing services such as animal tagging, doorstep veterinary services like vaccination, deworming, artificial insemination, and minor wound treatment. As the primary point of contact, these individuals will also be integrated with the Maha pashudhan Sanjeevani of Bhoom and Kalamb Taluka, Dharashiv district. BFIL through its CSR fund will provide Work-based compensation to women led A-HELP cadres for providing the veterinary services.

The MoU was signed and exchanged in the presence of Shri Srinivas Reddy Vudumula, Chief People officer and Head - CSR, BFIL, Shri Sachindra Pratap Singh, IAS, Commissioner Animal Husbandry, GoM, Dr. Hemant Vasekar, IAS, CEO, MSRLM in the presence of Shri Radhakrishna Vikhe Patil, Hon'ble Minister Animal Husbandry and Shri J P Gupta, IAS, Principal Secretary, AH, Dr. Prem Nath Singh, Sr. Lead Manager CSR & other officials from IndusInd bank and AHD.
